Voice Repertoire:

* Contestants in VW I will present TWO selections chosen from the following and time limit will be FIVE minutes.

* Contestants in VW II will present TWO selections chosen from the following and time limit will be SEVEN minutes.

a One aria from an opera or oratorio (original language)

b One German lied or art song sung in French or Italian

c One contemporary song (English)

Winds Repertoire:

* Contestants in VW I will present ONE piece and time limit will be FIVE minutes.

* Contestants in VW II will present ONE piece and time limit will be SEVEN minutes.

COMPETITION REQUIREMENTS

- * The competition is open to students of all active members in good standing of the Los Angeles County Branch. Students must have studied at least six months with their current teacher before entering.
- * There will be a total of Four Prizes awarded (in addition to Honorable Mentions) in each age category at the discretion of the judges. FIRST place winners are required to perform and all prize winners **MUST** be present to receive their scholarships at the Awards Concert. Failure to appear will result in the forfeiture of the award and prize money.
- * With the exception of the Voice and Winds categories, each teacher may only send ONE student per age category. Contributory member may send up to two entries maximum in total. There must be a minimum of four entries in order to proceed in any category.
- * Voice and Winds contestants will be judged together in two age categories (VW I and VW II)
- * Each application will be accompanied by a non-refundable entrance fee. The student's age, as of the competition date, May 4, 2019, will determine the appropriate category for entry. A copy of birth certificate or passport must be enclosed with the application.
- * All entries must be postmarked by April 6, 2019. LATE APPLICATIONS WILL NOT BE ACCEPTED. One check per teacher (including fees of all participating students) must be made out to: *MTAC, Los Angeles Branch*.
- * Students are expected to arrive at least twenty minutes in advance of their scheduled audition time. Each performer must bring scores of all repertoire played, with pages clipped open and measures numbered for judges' reference.
- * Any personal communication with the judges from students, parents, or teachers, will result in the disqualification of the contestant.
- * All music must be memorized. Repertoire listed on the application **MUST** be performed at the competition and can not be changed.
- * Judges will stop the audition at their discretion within the time limit. This will not affect the scores.
- * Awards are made at the discretion of the judges and judges' decisions are final. There will be NO Ties. Teachers of winning students will be notified by email within 24 hours.
- * Teachers should contact the chairperson if there are any questions.
